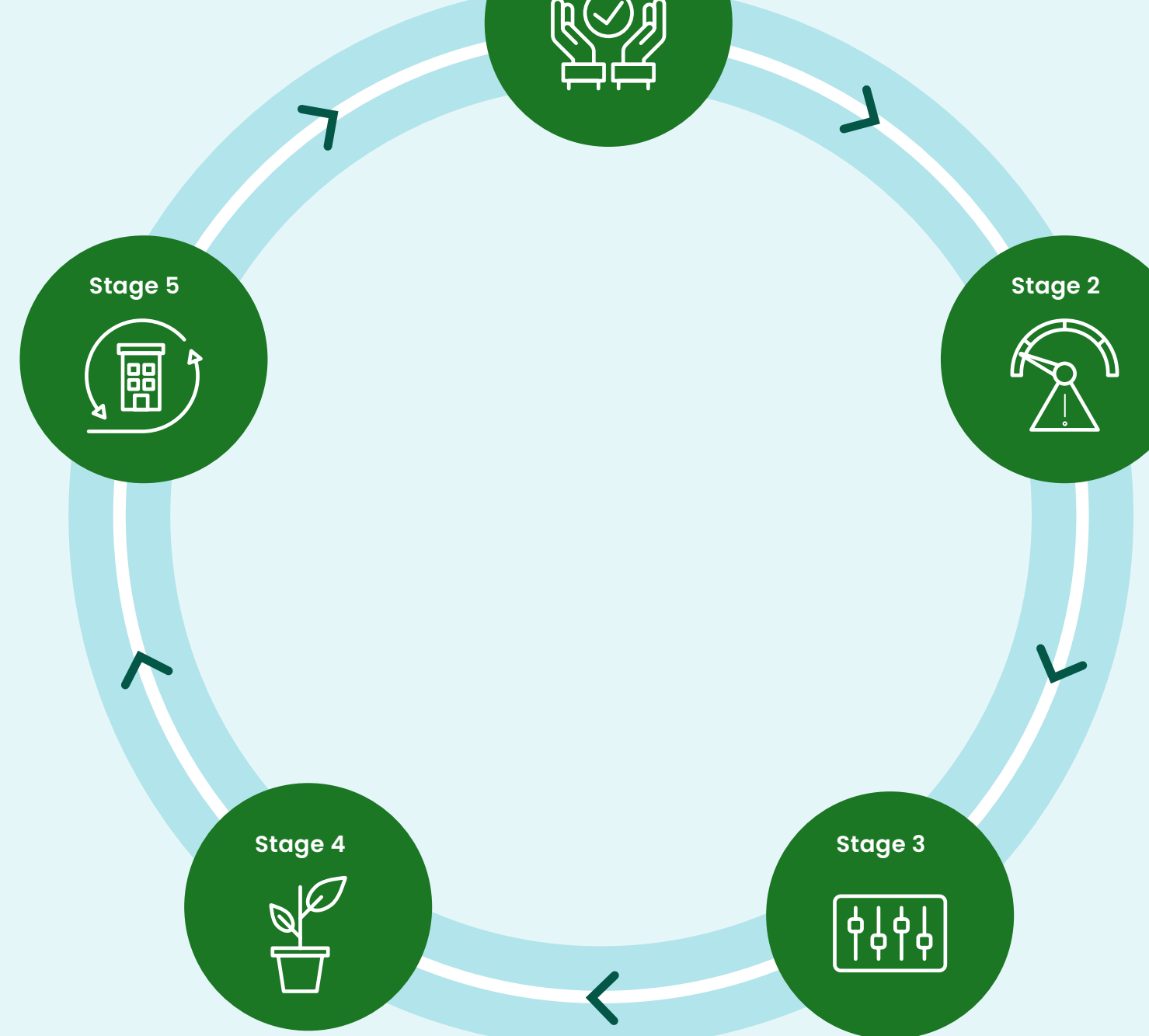

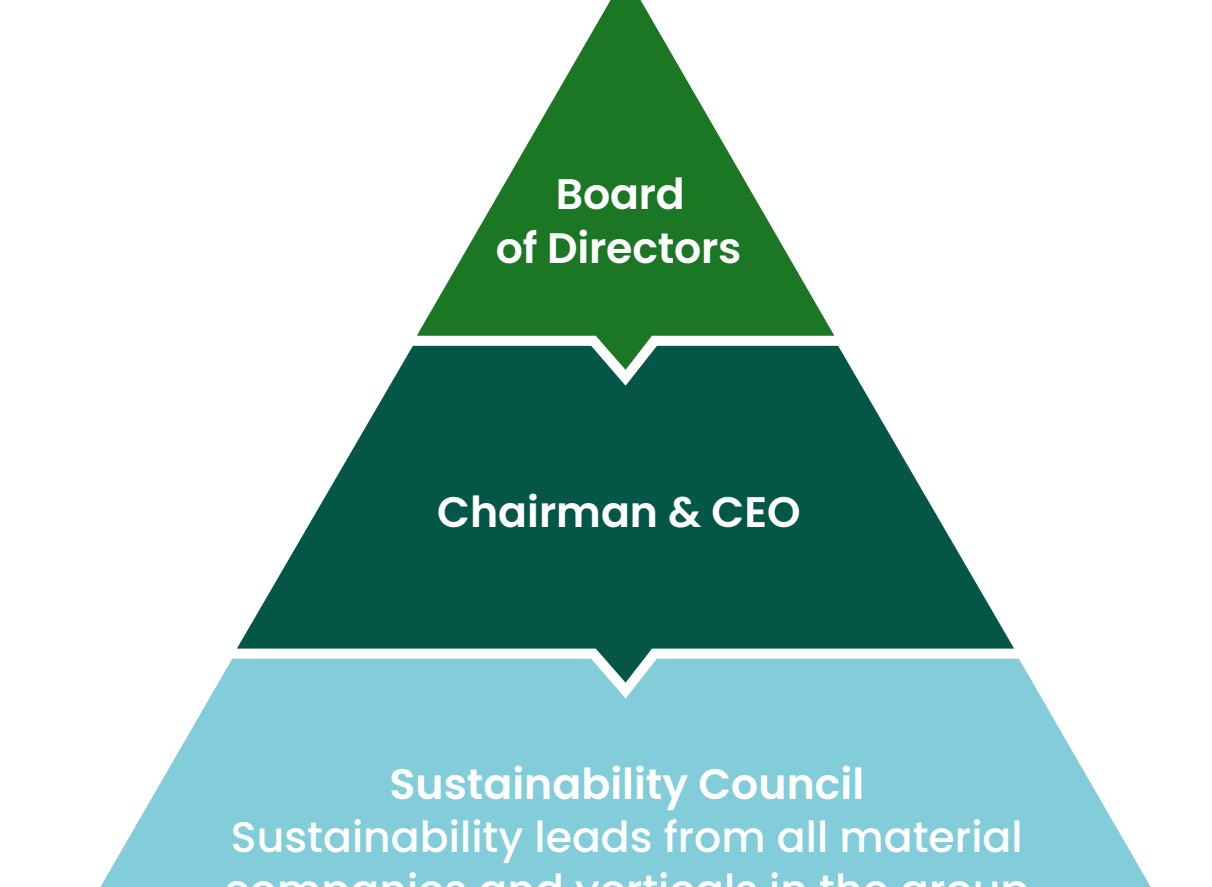
Governance
